Negotiations and fee/scope reviews related to additional Basic Services needed for the TPCG Lake Boudreaux Living Mitigation project which were initiated on March 01, 2022.

The additional services to be provided will include, but not be limited to:

Post construction time related to Project Management, Construction Administration, and Inspection Services for the supplemental planting of plants during appropriate growing season.

The CDBG Manager provided Fenstermaker with a draft format for a Cost/Price Summary related to the needed services, which format is a breakdown of fees based on man-hours and hourly labor rates and overhead and profit.

On March 28, 2022, Fenstermaker provided an initial price proposal for the additional services totaling approximately \$16,064.

The Independent Cost Estimate (ICE) totaled \$13,160. The difference in cost between the ICE and the fee offered by Fenstermaker are not significant enough to warrant further negotiations or explanations as to variances.

Based on prior evaluations, the CDBG Manager believes that the offered fixed fee presented appears to be reasonable in accordance with applicable provisions of 2 CFR 200.

The CDBG Project Manager reported to Fenstermaker and to the Owner that it was his opinion that the offered lump sum fixed fee for the requested professional service appeared to be reasonable based on his understanding of the scope of work.

The draft "Amendment 3 to Agreement for Professional Services between the Terrebonne Parish Consolidated Government and Fenstermaker for the LASAFE Lake Boudreaux Living Mitigation Project" was reviewed. The Amendment appeared to meet CDBG program requirements.

WHEREAS, an Agreement for Professional Services between the TERREBONNE PARISH CONSOLIDATED GOVERNMENT, LOUISIANA (OWNER) and FENSTERMAKER AND ASSOCIATES, LLC () was entered into on April 13, 2020; and,

WHEREAS, additional LASAFE funding has been awarded to the Terrebonne Parish Consolidated Government by the LA Division of Administration, Office of Community Development to increase the number of terraces to be constructed (See "EXHIBIT A" – Scope of Work Narrative & "EXHIBIT B" – General Location of Work Sketch); and,

WHEREAS, the additional funding necessitates an increase in the original scope of work to be completed by the ENGINEER for the Project; and

WHEREAS, the DESIGN PROFESSIONAL has submitted a proposal for additional fees in the amount of <u>one hundred ninety-five thousand two hundred fifteen dollars</u> (\$195,215), that would provide necessary project design, surveying, and project representation for the Lake Boudreaux Living Mitigation Project; and,

WHEREAS, after consultation with the CDBG Grant Manager and completion of the cost reasonableness review, it was determined that an Amendment to the Contract to allow for the additional work and to allow for additional compensation to the DESIGN PROFESSIONAL in the amount of one hundred ninety-five thousand two hundred fifteen dollars (\$195,215) is appropriate; which noted lump sum fee is deemed reasonable and appropriate, and was calculated on estimated man hours and labor rates and a separate calculation of profit as shown on attached "EXHIBITS C, D, and E."

NOW THEREFORE, the OWNER and DESIGN PROFESSIONAL do mutually agree that this Amendment No. 4 shall amend the lump sum fixed fee established in the original Agreement to provide that the DESIGN PROFESSIONAL will be compensated for the additional services performed as an additional phase for the Terrebonne Parish Lake Boudreaux Living Mitigation Project and accordingly the CONTRACT shall be amended as follows:

Add paragraph 5.1.4.9 as follows:

5.1.4.9 Phase 2 Construction Contract Services, for services rendered by DESIGN PROFESSIONAL in accordance with Paragraph 5.1.4., a lump sum fixed fee of One hundred ninety-five thousand two hundred fifteen dollars (\$195,215) for all related survey, engineering and design, bid phases services, construction administration and inspection services performed during phase 2 for the Lake Boudreaux Living Mitigation Project, which lump sum fixed fee was calculated on estimated manhours, rates, and profit as indicated in "EXHIBITS C, D and E".

Payment Schedule for Basic Services shall be according to Paragraph 5.1.3. of the original Agreement. Payment for Survey Services shall be based on a percentage of completion of the Task and 100% upon submission and receipt of a deliverable indicating the Survey Record. Payment for Construction Observation shall be based on the percentage of construction complete.

FURTHER, the Design Professional upon completion of the bidding documents (Final Plans) shall certify that the design meets the appropriate code or industry design and appropriate construction standard (Refer to Paragraph 1.5.23 of the Agreement).

FURTHER, for services rendered under this Amendment, the DESIGN PROFESSIONAL shall complete the duties for the Design Phase and shall submit Contract Documents and an Opinion of Cost to the OWNER and the CDBG Administrator within 365 calendar days of receipt of a Notice to Proceed from the OWNER. The provisions for the right by the Owner to grant an extension for reasons beyond control of the DESIGN PROFESSIONAL are as noted in Paragraph 1.3.8 of the Agreement. If the Design Phase for the Scope of Work under this Amendment is not completed by the established deadline, a fee of \$350 per working day will be deducted from the Basic Fee for the Services under this Amendment due to the DESIGN PROFESSIONAL until the Design Phase is complete.

Terrebonne Parish intends to implement a Phase II for the Lake Boudreaux Living Mitigation Project to install additional terraces. A total of \$1,085,689 dollars had been allocated for Phase II.

Additional services required to implement Phase II include Basic Services for development of bidding documents and construction administration. Topographic type Surveys of the proposed area of new terracing requiring water transport of Survey Crews to the submerged low-lying areas. The survey area will be surveyed for depth of bottom and magnetometer for location of existing buried or submerged pipelines. Upon award of a construction contract, on-site observation of installation of the terrace will be provided.

On April 4, 2022, Fenstermaker provided a draft Amendment No. 4 for Basic Services, Survey Services and Construction Observation.

Cost or Price Summary sheets for each of the services was provided that included estimated man hours by job classification; indirect overhead; direct cost and equipment; and profit for each of the services required under the Amendment.

The CDBG Grant Manager was tasked to undertake a review of the Amendment and the fees proposed.

On early review, the CDBG Grant Manager noted that the fees for Basic Services did not appear reasonable for what was presently understood to be the scope of work. A conference call was requested with Fenstermaker to discuss the fees proposed, assumed man hours, and cost, etc.

A conference call was held on April 6, 2022, with Danny Dehon with Fenstermaker, Leesa Foremen with OCD; Julie Bordelon with OCD and Thomas David with OCD. Mr. David requested that Fenstermaker outline the types of survey work required, challenges offered in the design effort etc., in an effort to justify fees proposed. Mr. Dehon outlined the proposed scope of services for this Amendment. Mr. David commented that it was hoped that from lessons learned and experience gained from Phase I that cost for Basic Services would be less than proposed. Mr. Dehon reported that exactly the opposite in that from Phase I they learned that a significant effort was required to develop plans for viable terraces. Mr. Dehon reported that for Phase I, on review of cost incurred, indicated a very minimal profit and experience gained indicated more man-hours are required than was originally expected. They reported that Ducks Unlimited would be a technical advisor on this phase in an effort to reduce cost, as opposed to undertaking actual design work. Mr. David requested that a reevaluation of Basic Services was needed. Fenstermaker proposed a Basic Services fee totaling \$124,103. The Survey fee was proposed for \$65,000. The Project Representative fee was proposed at \$35,000.

On April 18, 2022, Fenstermaker provided a revised and reduced fee for Basic Services, which totaled \$95,366. The fees proposed for Project Representation and Surveys remained the same.

Regarding Basic Services, Fenstermaker's revised proposal resulted in a 23.1% reduction in cost. The man hours appeared reasonable for the Scope of Work. The effective hourly rates for the various job classifications were reviewed and were deemed reasonable, when compared to LDOTD statewide average rates. The Basic Services estimated 746 total man hours would be required to complete the project. This fee resulted in an average hourly professional rate of \$125.73 per hour. The profit percentage was calculated at 3%. The Basic Services fee is reasonable.

Regarding the Survey work, this work requires utilization of offshore boats and airboats. The site is remote, and production is slow. The proposal includes 125 hours for a survey crew. Assuming a 10-hour workday, a total of 12.5 field survey days would be required. Considering the area to be surveyed, the 12.5 days is reasonable. The three-man survey crew hourly rate of \$165 per hour is reasonable when compared to LDOTD statewide averages. The profit percentage equals 8% and is reasonable for this level of effort. The equipment charges for the boat, airboat, and magnetometer are reasonable when compared to historical charges.

Regarding Project Representation, a total of 340-man hours is estimated. The hourly rate of \$75 per hour is reasonable for a field technician and compares favorably to the LDOTD statewide average rate for this job classification. Profit was calculated at 6% and is also reasonable for this level of effort.

Based on the review of the scope of work, estimated man hours, labor classifications, equipment costs, and profit, the CDBG Manager believes that the proposed fixed fees as presented by Fenstermaker for services rendered under Amendment No. 4 a reasonable, in accordance with applicable provisions 2CFR200.

The draft Amendment was reviewed, and the following edits were recommended:

- 1. Include narrative defining Scope of Work
- 2. Provide sketch or Google Earth image defining general limits of survey work and terraces.
- 3. Include metric for delivery of bidding documents and opinion of cots, and penalty for failure to meet deadline.
- 4. Include reference to PL113-2, regarding certification by Design Professional of design documents meeting applicable codes.

A revised draft of the Amendment was prepared that included the noted items.
