### PROJECT TITLE

RESOLUTION: Authorizing the Parish President to Hire a Surveying Firm to Attempt to Determine the Boundary between Lafourche Parish and Terrebonne Parish, Concerning a Tract of Land Located on the Eastern Side of Terrebonne Parish on the Bourg Larose Highway, in Particular Parcel No. 29789, and/or to Enter into a Cooperative Endeavor Agreement or Intergovernmental Agreement with Lafourche Parish Government Concerning the Survey and/or Sharing the Costs thereof; and to Provide for Related Matters thereto

**WHEREAS**, Parish Administration recommends to the Terrebonne Parish Council that the Parish President, Gordon E. Dove, be authorized to hire a surveying firm to determine if the boundary line between Terrebonne Parish and Lafourche Parish concerning a tract of land located on the eastern side of Terrebonne Parish on the Bourg Larose Highway, in particular Parcel No. 29789, can be ascertained in an effort to resolve this dispute and/or to enter into a Cooperative Endeavor Agreement or Intergovernmental Agreement with Lafourche Parish Government concerning the survey and the costs thereof if deemed necessary; and
