RESOLUTION OF THE TERREBONNE PARISH Α COUNCIL, STATE OF LOUISIANA, ORDERING AND CALLING A SPECIAL ELECTION TO BE HELD IN THE PARISH OF TERREBONNE, STATE OF LOUISIANA, TO REAUTHORIZE THE LEVY OF A SPECIAL TAX THEREIN; MAKING APPLICATION TO THE STATE BOND COMMISSION IN CONNECTION THEREWITH; AND PROVIDING FOR OTHER MATTERS IN **CONNECTION THEREWITH**

BE IT RESOLVED by the Terrebonne Parish Council of the Parish of Terrebonne, State of Louisiana (the "Governing Authority"), acting as the governing authority of the Parish of Terrebonne, State of Louisiana (the "Parish"), that:

SECTION 1: Election Call. Subject to the approval of the State Bond Commission, and under the authority conferred by Article VI, Section 26 of the Constitution of the State of Louisiana of 1974, the applicable provisions of Chapter 5 and Chapter 6-A of the Louisiana Election Code, and other constitutional and statutory authority, a special election is hereby called and ordered to be held in the Parish on October 14, 2023, with the polls to open at 6:00 a.m., and close at 8:00 p.m., in accordance with the provisions of La. R.S. 18:541, and at the said election there shall be submitted to all registered voters qualified and entitled to vote at the said election under the Constitution and laws of this State and the Constitution of the United States, the following propositions, to-wit:

PROPOSITION I (Rededication)

Shall the Parish of Terrebonne, State of Louisiana (the "Parish"), be authorized to repurpose the revenue of one (1) mill of the already authorized special tax of one and sixty-six hundredths (1.66) mills on all property subject to taxation in the Parish (the "Tax") authorized pursuant to an election held on November 6, 2012, and ending in the year 2030, currently dedicated and used for the purpose of acquiring, constructing, operating and maintaining the Terrebonne Parish Health Unit and health unit facilities and rededicate the revenue of one (1) mill of that special tax to provide additional funds for improving, operating, providing and maintaining public safety personnel, pedestrian facilities and at school sites within the Parish (an estimated \$982,768.66 reasonably expected to be collected from the levy of the Tax for an entire year)?

SECTION 2: Publication of Notice of Election. A Notice of Special Election shall be

published in The Houma Courier, a newspaper of general circulation within the Parish, published

in Houma, Louisiana, and being the official journal of the Parish, once a week for four (4) consecutive weeks, with the first publication to be made not less than 45 days nor more than 90 days prior to the date of the election, which Notice shall be substantially in the form attached hereto as "**Exhibit A**" and incorporated herein by reference the same as if it were set forth herein in full.

SECTION 3: <u>Canvass</u>. This Governing Authority shall meet at its regular meeting place, the Government Tower Building, 8026 Main Street, Houma, Louisiana, on **October 25 2023, at 6:00 PM,** and shall then and there in open and public session proceed to examine and canvass the returns and declare the result of the said special election.

SECTION 4: <u>Polling Places</u>. The polling places set forth in the aforesaid Notice of Special Election are hereby designated as the polling places at which to hold the said election, and the Commissioners-in-Charge and Commissioners, respectively, will be the same persons as those designated in accordance with law.

SECTION 5: <u>Election Commissioners; Voting Machines</u>. The officers designated to serve as Commissioners-in-Charge and Commissioners pursuant to <u>Section 4</u> hereof, or such substitutes therefor as may be selected and designated in accordance with La. 

WHEREAS, Sheriff has requested assistance from TPCG to support its effort to staff schools outside of the limits of the City of Houma; and

WHEREAS, TPCG wishes to assist Sheriff by providing him with five patrol units dedicated to use by school resource officers in Terrebonne Parish in consideration of Sheriff's dedication of these vehicles to its school resource officer program; and

WHEREAS, a copy of the Intergovernmental Agreement is attached and made a part of and incorporated into this Resolution; and

INTERGOVERNMENTAL AGREEMENT BETWEEN TERREBONNE PARISH CONSOLIDATED GOVERNMENT AND TERREBONNE PARISH SHERIFF'S OFFICE FOR SCHOOL RESOURCE OFFICER VEHICLES

THIS AGREEMENT made and entered into on the dates inscribed below by and between

I. PARTIES

- 1.1 Terrebonne Parish Consolidated Government, a political subdivision of the state of Louisiana, with a mailing address of PO Box 2768, Houma LA 70361, represented herein by its duly authorized Parish President by virtue of Terrebonne Parish Council Resolution No. ______, or his duly authorized Designee by virtue of that certain Act of designation filed for record in Terrebonne Parish COB Entry No. 1627089, hereinafter referred to as "TPCG"; and
- 1.2 Sheriff Timothy Soignet, on behalf of the Terrebonne Parish Sheriff's Office, whose mailing address is PO Box 1670, Houma LA 70361, hereinafter referred to as "Sheriff";

who agree as follows:

II. PREAMBLES

2.1. WHEREAS, LA R.S. 33:1324, also known as the Local Services Act, provides that any parish or political subdivision of the state may make agreements between or among themselves to engage jointly in the acquisition or improvement of any public project or improvement provided that at least one of the participants to the agreement is authorized under a provision of law to perform such activity for completion of the undertaking; and

2.2. WHEREAS, the TPCG and Sheriff recognize the need and advantage of school resource officers within Terrebonne Parish, and they are committed to the ultimate goal of stationing school resource officers in all Terrebonne Parish Schools; and

2.3. WHEREAS, the TPCG and Sheriff both have the authority and desire to provide for school resource officers within schools in the Parish of Terrebonne; and

2.4. WHEREAS, to facilitate these goals, in September 2022, the Terrebonne Parish Council adopted Ordinance No. 9421, which allocated \$1,000,000.00 in funding from its allotment under the American Rescue Plan for the purchase of vehicles for school resource officers; and

2.5. WHEREAS, Sheriff has requested assistance from TPCG to support its effort to staff schools outside of the limits of the City of Houma; and

2.6. WHEREAS, TPCG wishes to assist Sheriff by providing him with five patrol units dedicated to use by school resource officers in Terrebonne Parish; and

2.7. NOW THEREFORE, for and in consideration of the covenants and compensation provided for herein, and for other good and valuable considerations acknowledged, the parties do agree as follows:

III. OBLIGATIONS AND CONSIDERATION

- 3.1. In consideration for the Sheriff's obligations described below, TPCG shall:
 - 3.1.1. Identify and/or purchase five (5) new police vehicles of its choice and at its expense for use by Sheriff;
 - 3.1.2. Notify Sheriff when those five vehicles are delivered and ready for pickup;
 - 3.1.3. Assist Sheriff in obtaining documentation on those vehicles and registering the vehicles in the name of the Sheriff;
 - 3.1.4. Make an inventory of those vehicles for purposes of supplementing this Agreement upon delivery and registration to the Sheriff.
- 3.2. In consideration of TPCG's contribution of resources, the Sheriff shall:
 - 3.2.1. Arrange for pickup of the new vehicles upon notification by the TPCG;
 - 3.2.2. Register the new vehicles in the name of the Sheriff at its expense;
 - 3.2.3. Affix, at Sheriff's expense, the Sheriff's usual logos and markings to each vehicle;
 - 3.2.4. Affix the wording "School Resource Officer" in conspicuous lettering/font and in a conspicuous location on each vehicle;
 - 3.2.5. Maintain automobile liability insurance with a minimum limit of \$1,000,000 per claim and automobile physical damage insurance on these vehicles in the amounts necessary to cover any repairs and/or replacement of any of the vehicles damaged or destroyed by fault of either the Sheriff, his employees, a third party, or by any act of God or force of nature;
 - 3.2.6. Use any insurance proceeds obtained due to a total loss of one of these vehicles as funding for the purchase of a replacement school resource officer vehicle;
 - 3.2.7. Maintain the vehicles and their equipment in good working order, including any necessary body work, and in compliance with manufacturer warranty requirements;
 - 3.2.8. Assign these vehicles, for the life of the vehicles, for use by the Sheriff's school resource officers at the schools of the Sheriff's choice within Terrebonne Parish, Louisiana;
 - 3.2.9. Provide TPCG with an annual report on or around January 1 of each year, regarding the status of the vehicles, a statement regarding whether they are still in use by school resource officers and at which schools, and if not in use at schools, an explanation regarding their disposition; and
 - 3.2.10. Refrain from using these vehicles for any purpose other than those set forth herein, except that these vehicles may be used in the event of an emergency, disaster, or in the aftermath and recovery thereof.

IV. TERM and TERMINATION

4.1. The term of this agreement shall be for the life of the last vehicle transferred herein, or its replacement if a replacement was procured using insurance proceeds.

4.2. The parties may terminate this agreement by a subsequent written mutual agreement.

4.3. In the event this Agreement is terminated for any reason, the following provisions shall survive termination:

- 4.3.1. any indemnification obligations owed by Sheriff to Owner;
- 4.3.2. any insurance coverage owed by Sheriff necessary to cover any claims against either party arising under the terms of this Agreement;

V. DEFAULT

If Sheriff should breach any obligations of this agreement, TPCG shall give Sheriff fourteen (14) days written notice to correct same. If the deficiency is not corrected within the fourteen-day period (or if remediation is not begun within the 14-day period for those deficiencies which require additional time), TPCG may, at its option, and upon written demand or notice, remedy the deficiency at Sheriff's expense or make demand for the return of the vehicle from which the default arises. Sheriff shall then be obligated to deliver to TPCG the vehicle, or the fair market value thereof, plus any costs or expenses to effectuate the transfer of title, as necessary.

VI. INDEMNIFICATION

6.1. The Sheriff agrees to defend, indemnify, save, and hold harmless the Terrebonne Parish Consolidated Government, including all parish departments, agencies, councils, boards and commissions, their officers, agents, servants and employees, including volunteers, from and against any and all claims, lawsuits and demands for damages under any theory of liability as allowed by law, whether contractual, tortuous, or implied, arising from this agreement, whether for breach of contract, injury or death to any person, or for the damage, loss or destruction of any property, including loss of use, which may occur or in any way grow out of any breach, act or omission, whether intentional or unintentional, and any negligence, or liability of Sheriff, its subcontractors, agents, servants, officers and/or employees, related to the performance or nonperformance of the Contract herein entered into. Including, and as a result of any such claims, lawsuits and demands, the Sheriff agrees to investigate, handle, respond to, provide defense for and defend any such claims, demands or suits related thereto, at its sole expense, even if such claim, demand or suit is groundless, false or fraudulent. Damages are defined to include, but not be limited to, general, special, punitive, exemplary, delay, attorney fees, court costs, fines, penalties, interest, and/or expenses.

6.2. In the event of joint and concurrent negligence of both Sheriff and TPCG, responsibility and indemnity, if any, shall be apportioned comparatively in accordance with the laws of the State of Louisiana, without, however, waiving any government immunity available to TPCG under Louisiana law and without waiving any defenses of the parties hereto.

VII. <u>NOTICES</u>

7.1. Whenever any provision of the Contract Documents require the giving of written notice, it will be deemed to have been validly given if delivered in person to the individual or to a member of the firm or to an officer of the corporation for whom it is intended, or if delivered at or sent to by registered or certified mail, postage prepaid, to the other party, addressed of the parties first listed above.

7.2. Either party may change its address for notice by submitting notice to the other party in writing as directed in this section.

VIII. ADDITIONAL TERMS AND CONDITIONS

8.1. The failure of TPCG to enforce any or all of the terms or conditions of this Agreement or of any of the Contract Documents in particular instances shall not constitute a waiver of or preclude the subsequent enforcement of any or all of the terms and conditions of this Agreement or any of the Contract Documents.

8.2. If any term, covenant, condition, or provision of this Agreement or the application thereof to any person or circumstances shall, at any time or to any extent, be invalid or unenforceable, the remainder of this Agreement, or the application of such term, covenant, condition or provision to persons or circumstances other than those as to which it is held invalid or unenforceable, shall not be affected thereby, and each term, covenant, condition, and provisions of this Agreement shall be

valid and be enforced to the fullest extent permitted by law.

8.3. The privileges herein shall not be assigned in whole or in part in any manner except by operation of law, and SHERIFF shall not have the right to assign or sublease the rights granted herein, without the consent of the TPCG obtained beforehand in writing, and in case of such assignment, sublease or succession so consented to, all of the conditions and provisions herein shall apply to such substituted party or SHERIFF.

8.4. No amendment to this Agreement shall be effective unless it is in writing, signed by the duly authorized representatives of all parties.

8.5. No Partnership. Nothing contained herein shall be deemed or construed by the parties hereto, nor by any third party, as creating a relationship between the parties hereto other than the relationship of TPCG and SHERIFF herein. TPCG and Sheriff are independent parties, each acting free from control of the other, and neither party nor their employees shall be considered the employee of the other for any reason.

8.6. Force Majeure. Neither party shall be liable to perform the obligations herein in the event those obligations become impossible to perform due to (a) weather; (b) war or national conflicts or priorities arising therefrom; (c) strikes, lockouts, embargoes, fire, casualties, delays in transportation, shortages or unavailability of materials or labor, national emergency; (c) any other act, event or circumstance beyond such party's control and which (i) such party cannot overcome by the exercise of reasonable and diligent efforts and (ii) is not a result of the negligence or willful misconduct of such party (collectively, "Force Majeure").

8.7. Entire Agreement. No oral statements or prior written material not specifically incorporated herein shall be of any force or effect. Each party agrees that in entering into this Agreement, it relies solely upon the representations and agreements contained in this Agreement and no others. This Agreement, including the preambles first appearing herein and any attachments hereto and made a part hereof, constitutes the whole agreement of the parties regarding the transfer and operation of the vehicles herein and shall in no way be constituted, modified or supplemented, except by a written agreement executed by both TPCG and Sheriff.
