Rostan Solutions, LLC (EIN \_\_\_\_\_) a Louisiana limited liability company whose mailing address for the purposes herein is 8282 Goodwood Blvd., Suite W6, Baton Rouge LA 70806, represented by Kyle Jones, its duly authorized Vice President, by virtue of the authorizing document attached to hereto and incorporated herein, hereinafter designated as "Consultant";

who, in consideration of the covenants and agreements herein contained, to be performed by the parties hereto and of payments hereinafter agreed to be made, it is mutually agreed as follows:

# 2. ORIGINAL CONTRACT

The Parties to this Amendment and Addendum No. 1 entered into that certain Professional Services Agreement for grant and project management for FEMA Hazard Mitigation Assistance Programs, construction management, and ASCE-24 standards on August 5, 2021, by Consultant and on August 12, 2021 by Owner (hereinafter "Original Contract"). The Original Contract was filed for record on August 16, 2021, with the Terrebonne Parish Recorder of Mortgages at MOB 3278, page 255, Entry No. 1633344.

# 3. <u>PURPOSE</u>

The purpose of this Amendment and Addendum No. 1 is to: (1) correct the Terrebonne Parish Resolution number referenced in the Original Contract, (2) correct the Purpose of the Original Contract, as provided for in the authorizing resolution, and (3) add services for HMGP work for Hurricane Ida.

# 4. AMENDMENTS

#### A.

The Parties agree that the phrase "Terrebonne Parish Council Resolution No. 19-320" appearing in Section 1.1 of the Original Contract shall be and is hereby replaced with the phrase "Terrebonne Parish Council Resolution No. 21-269."

The parties agree that the first paragraph of Article II, Purpose, of the Original Contract shall be and is hereby amended to read, in its entirety, as follows:

#### **II. PURPOSE**

2.1 The purpose of this contract is for TPCG to retain by contract Rostan Solutions, LLC as a consultant for grant and project management to provide qualified personnel familiar with the FEMA Hazard Mitigation Assistance (HMA) programs, Building Resilient Infrastructure and Communities (BRIC) grant programs, construction management, and ASCE-24 standards. Consultant shall expedite recovery operations by developing and implementing as needed successful HMA and BRIC applications for the mitigation of repetitive loss structures in Terrebonne Parish.

All terms and conditions of the Original Contract not amended herein shall remain in full force and effect.

# TASK ORDER #2 OF THE PROFESSIONAL SERVICES AGREEMENT BETWEEN TERREBONNE PARISH CONSOLIDATED GOVERNMENT AND ROSTAN SOLUTIONS, LLC AS AMMENDED DATED \_\_\_\_\_, 2023

# FEMA HAZARD MITIGATION ASSISTANCE GRANT PROGRAM APPLICATION DEVELOPMENT SERVICES

Rostan Solutions, LLC (FIRM) shall provide application development services for the Hazard Mitigation Grant Program funding provided as a result of Hurricane Ida. PARISH shall pay FIRM a fee of no more than the values below for the identified grant applications or services as provided in the Amendment and Addendum 1 signed March 22, 2021. FIRM shall charge these fees to the grant as "Preaward/Application Development" and will pursue every avenue to earn the award of these costs. FIRM will also seek and include all preaward expenditures by the Parish for reimbursement.

FIRM is authorized to develop and support, through FEMA approval, applications for individual residences or businesses for nonstructural risk reduction efforts if needed and approved by the Parish administration. This task order specifies the development of a Wind Retrofit application to reduce wind damage during events.

Compensation for the application development and support will be capped as per the values in the Exhibit C attached comprised of the Section 5.7 from the Rostan proposal submission to the Parish dated June 7, 2021. Complete applicant packages meeting all data requirements for an HMGP approval will be considered eligible for per unit payment.

Lump Sum per Structure Application Development – Wind Retrofit \$635 per unit

The Performance Period for services for the application development is effective September 1, 2022. The HMGP application drafts will be delivered to the Parish no less than two weeks prior to the deadline set by GOHSEP, and final, complete applications to GOHSEP no later than one day prior to that state submission deadline. Extensions by GOHSEP and FEMA do not extend the due date/s without express written consent from the Parish.

Rostan will continue to support any requests for information from GOHSEP or FEMA until the application is awarded or denied and provide quarterly updates mailed through USPS and email to the applicants as to the progress throughout the processing period. This activity is part of the original scope of work and is not eligible for separate compensation.

MEMORANDUM OF UNDERSTANDING Between Terrebonne Ministerial Alliances, Inc. and Terrebonne Parish Consolidated Government

This memorandum of understanding ("MOU") is between **Terrebonne Ministerial Alliances**, **Inc.**, a 501(c)(3) registered in the US and a non-profit corporation formed and operating under the laws of the state of Louisiana, with a mailing address of PO Box 3212, Houma, LA 70361, herein represented by its duly authorized President, Reverend Vincent Fusilier by virtue of \_\_\_\_\_\_\_, hereafter known as ("TMA"), and **Terrebonne Parish Consolidated Government** a political subdivision of the state of Louisiana with a mailing address of PO Box 2768, Houma LA 70361, represented herein by its Parish President, Gordon E. Dove, by virtue of the authority granted by Terrebonne Parish Council Resolution No. \_\_\_\_\_\_, or his duly authorized designee, Michael C. Toups, Parish Manager, as authorized under that certain Act filed for record with the Terrebonne Parish Recorder of Conveyances at Entry No. 1627089 ("**TPCG**").

The parties therefore agree as follows:

# I. Purpose

The purpose of this Memorandum of Understanding (MOU) is to establish a working relationship between TMA and TPCG in exploring options and seeking funding for the redevelopment and revitalization of certain properties in the City of Houma.

TMA is an alliance of numerous local ministers, reverends, and volunteers who provide services to the citizens of Terrebonne Parish. TMA seeks to explore options to revitalize areas of the City of Houma damaged by Hurricane Ida and that have otherwise fallen into disuse and disrepair. In particular, TMA seeks to revitalize the strip mall located at 7468–7502 Main Street, Houma, LA 70360, site of the former "That Stanley" grocery store (hereinafter, the "Strip Mall"), to provide area residents with an easily accessible grocery, other retail stores, and a no-cost or low-cost venue for weddings, funerals, and similar special events. TMA further seeks to revitalize distressed and/or derelict residential properties for use as low- to moderate- income housing.

This Agreement provides the broad framework for cooperation and communication between TMA and TPCG in evaluating options for the redevelopment and revitalization of dilapidated properties in the City of Houma; as well as for other services for which cooperation may be mutually beneficial.

TPCG supports and encourages TMA's desire to redevelop and revitalize the aforementioned properties in the City of Houma.

TPCG finds that TMA's plans, as expressed, align with TPCG's Comprehensive Master Plan Vision 2030.

# II. TERM

2.1. **Term**. This Agreement shall be effective upon the date of final signature and shall remain in effect for three years.

2.2. **Termination.** Either party may terminate this MOU for any reason upon written notice to the representative of the other party first identified above.

2.3. **Periodic Review.** TMA shall, as needed, evaluate progress in the implementation of its goals and advise TPCG of its developed plans or goals as appropriate.

# III. PURPOSE

3.1. TMA and TPCG may endeavor to coordinate their efforts in exploring options for the redevelopment and revitalization of derelict areas of the City of Houma.

3.2. The primary goals of this MOU include:

- 3.2.1. identifying federal funding for redevelopment and revitalization efforts and identifying eligibility for such funding.
- 3.2.2. identifying the assistance, if any, that TPCG may provide to TMA in its redevelopment and revitalization efforts.

3.3. Because neither party owns any rights in the properties preliminarily identified for revitalization, the parties are unable to bind or obligate themselves at this time. Therefore, the obligations herein are non-binding, and any agreements for the implementation of plans for development or revitalization shall require a separate written contract, properly approved by the governing bodies of the parties, and subject to all applicable federal, state, and local laws and regulations. In all circumstances, each party is responsible for and liable to its own employees, representatives, responders, contractors, subcontractors, consultants, volunteers, and agents. This MOU is not intended to create any contractual relationship between TPCG and TMA's contractors, subcontractors, consultants, officers, directors, employees, representatives, agents, and volunteers. Likewise, the MOU is not intended to create any contractual relationship between TMA and TPCG's contractors, subcontractors, consultants, officers, directors, employees, employees, representatives, agents, and volunteers.

# IV. TMA'S ROLE

4.1. TMA will use its reasonable best efforts within its sole discretion to meet its responsibilities as outlined in this MOU.

- 4.2. TMA will provide a TMA Primary Contact List to TPCG.
- 4.3. TMA may perform the following:
  - 4.3.1. Identify with specificity locations targeted for redevelopment and revitalization and communicate this information to TPCG.
  - 4.3.2. Acquire ownership of those properties identified for redevelopment and revitalization.
  - 4.3.3. Determine potential funding sources for acquisition, redevelopment, and revitalization efforts.
  - 4.3.4. Communicate requirements for obtaining funding to TPCG.
  - 4.3.5. Develop specific plans for the acquisition, demolition, renovation, rebuilding, or building locations identified for redevelopment and revitalization and communicate these plans to TPCG.

4.4. TMA acknowledges that, should it successfully secure federal funding for its redevelopment and revitalization effort, the parties hereto will cooperate to enter into an appropriate agreement, or agreements, to effect TMA's redevelopment and revitalization plans.

4.5. TMA further acknowledges that a requirement for the potential agreement(s) mentioned in paragraph 4.4 herein above, shall be for TMA to obtain the necessary insurance policies and to follow all local, state, and Federal regulations related to the work.

# V. TPCG'S ROLE

5.1. Upon receipt of TMA's detailed plans for its redevelopment and revitalization efforts, TPCG will assist in identifying any funding or processes for which TMA may be eligible in order to facilitate its goals.

5.2. Upon receipt of detailed information from TMA regarding the requirements to obtain federal funding for the redevelopment and revitalization plan, TPCG will consider the reasonable effortsit may undertake to assist TMA in securing the funding.

5.3. Should TMA successfully secure federal funding for the project, TPCG will explore and may propose appropriate agreements between the parties to address all legal and contractual issues necessary for the work.

5.4 All actions identified herein by TPCG are subject to necessary and proper local, federal, and state approval processes and regulations.

# VI. LIABILITY AND INDEMNITY

6.1. Liability: Because this MOU is of a non-binding nature, no party to this agreement shall hold the other liable for any loss or expense, to include third party complaints or litigation, resulting from the actions or inaction of the other.

6.2. Indemnity: TMA shall defend, hold harmless and indemnify TPCG and its officers, agents, employees, volunteers and each of them in all capacities from and against all claims (including, and without limitation, claims for bodily injury, death, or damage to property), causes of action, lawsuits, costs, damages, fines, judgments, penalties, losses, liabilities or expenses (including, and without limitation, attorneys' fees and court costs) of every kind and nature whatsoever, which may arise from or in any manner arise directly or indirectly from any services or activities undertaken by TMA pursuant to this Memorandum of Understanding or TMA's presence or activities conducted in conjunction with this Memorandum of Understanding (including, without limitation, the negligent and/or willful acts, errors and/or omissions of TMA, its principals, officers, agents, employees, vendors, suppliers, subcontractors, anyone employed directly or indirectly by any of them or for whose acts they may be liable). This section shall not apply in the event of the sole negligence of TPCG or its officers, agents, employees, volunteers. All immunities under local, Louisiana, and Federal law are implicitly reserved herein by TPCG.

# VII. NONBINDING NATURE OF MOU; NONPARTNERSHIP

7.1. **Nonbinding.** This MOU is not binding or legally enforceable, imposes no enforceable obligations upon the parties and does not grant any rights.

7.2. **Nonpartnership.** This MOU does not constitute and shall not be construed as constituting any of the relationships of agency, partnership, or joint venture between the parties. Neither party shall have the right to bind the other party in any manner whatsoever. The parties are separate and independent organizations. Each is responsible for establishing its own policies and financing its own activities.

# VIII. MISCELLANEOUS

- 8.1. <u>Governing Law, Venue</u>. The validity, construction and performance of this MOU and all disputes between the parties arising out of this Agreement or as to any matters related to but not covered by this Agreement shall be governed by the laws of the state of Louisiana without regard to the to choice or conflict of laws provisions. Any litigation arising out of this MOU shall be filed and brought in the 32<sup>nd</sup> Judicial District Court in the Parish of Terrebonne, State of Louisiana.
- 8.2. <u>Assignment</u>. Neither this Agreement nor any rights under this Agreement may be assigned by any party without the prior written consent of the other party(ies).
- 8.3. <u>Amendment and Waiver</u>. This Agreement may be amended, modified or supplemented only by a writing executed by each of the parties. Any party may in writing waive any provisions of this Agreement to the extent such provision is for the benefit of the waiving party. No action taken pursuant to this Agreement shall be deemed to constitute a waiver of any other party's compliance with provisions of this Agreement. No waiver by any party of a breach of any provision of this Agreement shall be construed as a waiver of any subsequent or different breach, and no forbearance by a party to seek a remedy for noncompliance or breach by another party shall be construed as a waiver of any right or remedy with respect to such noncompliance or breach.
- 8.4. <u>Familiarity with Laws and Ordinances</u>. TMA shall familiarize itself with and shall comply with all applicable State and Federal laws, municipal ordinances, the order of command in local emergency and disaster operations, and any other pertinent regulations and protocol which may directly or indirectly affect the work or services of TMA.
- 8.5. Neither party shall be deemed the drafter of this MOU.
- 8.6. The mutual goals established in this MOU are not exclusive to the parties. Either party may, at its discretion and in its sole judgment, sign contracts for any work of any nature or kind that it may require when doing so best serves the redevelopment of derelict structures within the community.
- 8.7. Each party expressly declares and acknowledges that the other party is independent from the first, and, as such, it is expressly declared and understood between the parties hereto, that neither party, nor anyone employed or contracted by it shall be considered an employee

of the other for the purpose of unemployment compensation coverage and workers' compensation insurance.

8.8. If any term, covenant, condition, or provision of this Contract or the application thereof to any person or circumstances shall, at any time or to any extent, be invalid or unenforceable, the remainder of this Contract, or the application of such term, covenant, condition or provision to persons or circumstances other than those as to which it is held invalid or unenforceable, shall not be affected thereby, and each term, covenant, condition, and provisions of this Contract shall be valid and be enforced to the fullest extent permitted by law.

# IX. EXECUTION OF MOU



# PROJECT SUMMARY (200 WORDS OR LESS)

Terrebonne Parish Recreation in partnership with Nicholls State University will conduct the first Colonel/TPR eSports Summer Camp in Terrebonne Parish. The session will be from Monday July 10-Saturday July 15, 2023. Monday-Friday will be at the Parish Main Library and the Saturday session will be at the Colonel eSports Arena at the Nicholls Campus Student Union. The camp is offered at no cost to the participants. TPCG FY2023 Budget included the costs for camp. The first-year costs include the hardware, so future camps in subsequent years will be at a greatly reduced amount. The camp staff and logistics are provided by Nicholls thru the CEA.

# PROJECT PURPOSE & BENEFITS (150 WORDS OR LESS)

The TPR/Colonel Esports Summer Camp program will provide Terrebonne Parish student attendees with an opportunity for improved cognitive abilities, improved problem-solving skills and logic skills, increased hand-to-eye coordination, improved multi-tasking ability, faster and more accurate decision-making, enhanced empathetic behaviors, physical activity, improved perseverance, better pattern recognition, strategic thinking, risk-taking abilities, and management skills, in addition to offering non-native English speakers the ability to learn English faster using video games. The final day will also include participation from the parents/legal guardians.

A RESOLUTION AUTHORIZING THE PARISH PRESIDENT (OR ADMINISTRATION) TO EXECUTE A COOPERATIVE ENDEAVOR AGREEMENT WITH NICHOLLS STATE UNIVERSITY TO CONDUCT A COLONEL/TPR ESPORTS SUMMER CAMP AT THE TERREBONNE PARISH LIBRARY – MAIN BRANCH AND AN OPEN HOUSE AT THE NICHOLLS STATE ESPORTS ARENA JULY 10-15, 2023.

**WHEREAS**, Article VII, Section 14 of the Louisiana Constitution further provides that "For a public purpose, the state and its political subdivisions or political corporations may engage in cooperative endeavors with each other, with the United States or its agencies, or with any public or private association, corporation or individual"; and,

WHEREAS, Section 1-05. of the Terrebonne Parish Charter provides that "The parish government shall have and exercise such other powers, rights, privileges, immunities, authority and functions not inconsistent with this charter as may be conferred on or granted to a local governmental subdivision by the constitution and general laws of the state, and more specifically, the parish government shall have and is hereby granted the right and authority to exercise any power and perform any function necessary, requisite or proper for the management of its affairs, not denied by this charter, or by general law, or inconsistent with the constitution"; and,

WHEREAS, the Louisiana Constitution Article VI, Section 20, Louisiana Revised Statutes 33:1324, and Section 1-07 of the Terrebonne Parish Charter provides "the parish government is authorized, as provided by state law, to enter into joint service agreements or cooperative efforts with other governmental agencies and political subdivisions"; and,

WHEREAS, TPCG finds that an agreement with Nicholls State University, according to the terms of this cooperative endeavor, has a public purpose of offering Terrebonne Parish students an educational and recreational activity at no cost to them through the Colonel Esports Summer Camp; and,

WHEREAS, a copy of the proposed agreement is attached to this resolution and incorporated herein; and,

WHEREAS, Colonel Esports is the official Esports Team of Nicholls State University; and,

WHEREAS, TPCG finds that the Colonel Esports Summer Camp program will provide Terrebonne Parish student attendees with an opportunity for improved cognitive abilities, improved problem-solving skills and logic skills, increased hand-to-eye coordination, improved multi-tasking ability, faster and more accurate decision-making, enhanced empathetic behaviors, physical activity, improved perseverance, better pattern recognition, strategic thinking, risk-taking abilities, and management skills, in addition to offering non-native English speakers the ability to learn English faster using video games; and,

WHEREAS, TPCG's 2023 adopted budget included funds in the amount of Sixty-Five Thousand Dollars (\$65,000.00) for the purchase of necessary hardware and equipment to commence its first Esports camp and for the payment to Nicholls State University for the administration of the Colonel Esports Summer Camp; and,

**WHEREAS**, TPCG finds that, after the initial hardware investment (software is purchased by Nicholls), it will be able to provide, in conjunction with Nicholls State University, the Colonel Esports Summer Camp for Terrebonne Parish students in ensuing years at a greatly reduced cost; and,

WHEREAS, TPCG finds that the expenditure of its public funds in consideration of the launch of an Esports Summer Camp in Terrebonne Parish as established in the attached

Cooperative Endeavor Agreement, taken as a whole, is not gratuitous, and TPCG has a reasonable expectation of receiving a public benefit in at least similar value in return of its public expenditures; and,

**NOW, THEREFORE, BE IT RESOLVED** by the Terrebonne Parish Council, on behalf of the Terrebonne Parish Consolidated Government, that the Parish President (or his duly authorized designee) is hereby authorized to execute a Cooperative Endeavor Agreement between the Terrebonne Parish Consolidated Government and Nicholls State University for the purposes set forth herein, with terms and conditions not materially different that those in the attached proposed agreement, subject to the legal department's approval.

# COOPERATIVE ENDEAVOR AGREEMENT BETWEEN TERREBONNE PARISH CONSOLIDATED GOVERNMENT AND NICHOLLS STATE UNIVERSITY

This Cooperative Endeavor Agreement ("Agreement") has been entered into on the dates set forth herein by and between:

# I. <u>PARTIES</u>

- 1.1 **TERREBONNE PARISH CONSOLIDATED GOVERNMENT**, (herein sometimes referred to as "TPCG"), PO Box 2768, Houma LA 70361, a political subdivision of the State of Louisiana, herein represented by Gordon E. Dove, President of Terrebonne Parish Consolidated Government or his duly authorized Designee, Michael C. Toups, Parish Manager, and
- 1.2 **NICHOLLS STATE UNIVERSITY** (herein sometimes referred to as "NICHOLLS"), a public university, authorized to do and doing business in the Parish of Lafourche, State of Louisiana, whose mailing address for the purposes herein is 906 East 1st Street, PO Box 2033, Thibodaux, LA 70301, herein represented by its duly authorized President, Dr. John Clune;

who, in order to serve the public for the purposes hereinafter stated, declared and acknowledged, as follows:

# II. <u>PREAMBLES</u>

2.1 **WHEREAS**, Article VII, Section 14 of the Louisiana Constitution further provides that "For a public purpose, the state and its political subdivisions or political corporations may engage in cooperative endeavors with each other, with the United States or its agencies, or with any public or private association, corporation or individual"; and,

2.2 WHEREAS, Section 1-07 of the Terrebonne Parish Charter provides "the parish government is authorized, as provided by state law, to enter into joint service agreements or cooperative efforts with other governmental agencies and political subdivisions"; and,

2.3 **WHEREAS**, La. Const. Art. VII, Section 14 (B) authorizes TPCG to utilize public funds for programs of social welfare for the aid and support of the needy; and,

2.4 **WHEREAS**, TPCG budgeted \$65,000.00 to assist NICHOLLS with the costs associated with the hosting of a Colonel Esports Summer Camp for Terrebonne Parish Youth; and,

2.5 **WHEREAS**, Colonel Esports is the official Esports Team of Nicholls State University; and,

2.6 **WHEREAS**, the Colonel Esports Summer Camp will serve a public purpose and benefit to residents of Terrebonne Parish and is not gratuitous in light of the benefits provided; and,

2.7 **WHEREAS**, TPCG and NICHOLLS desire that this Agreement be formed by and between themselves as a demonstration of their common interest of providing recreational opportunities to Terrebonne Parish residents; and,

2.8 **WHEREAS**, both TPCG and NICHOLLS have a reasonable expectation of receiving a benefit or value described in detail that is at least equivalent to or greater than the consideration

described in this Agreement; and,

2.9 WHEREAS, the transfer or expenditure of public funds or property is not a gratuitous donation;

2.10 WHEREAS, TPCG and NICHOLLS would like to enter into a Cooperative Endeavor Agreement in the amount of \$17,428.00 to provide for the Colonel Esports Summer Camp in Terrebonne Parish; and

2.11 NOW THEREFORE, in consideration of the mutual covenants herein contained, the Terrebonne Parish Consolidated Government and Nicholls State University, each represented by the undersigned, duly authorized to act herein respectively, agree to the following:

## III. **PURPOSE**

TPCG is partnering with NICHOLLS, an entity of the State of Louisiana, to reimburse 3.1. funding for the Colonel Esports Summer Camp. The Camp will be hosted at the Terrebonne Parish Library - Main Branch which is located at 151 Library Drive, Houma LA 70360 and serves the residents of Terrebonne Parish.

## **SCOPE OF SERVICES and CONSIDERATION** IV.

4.1 It is agreed between the parties:

# 4.1.1. NICHOLLS shall:

4.1.1.1.	Use the funds provided by the TPCG to acquire games and software and to host the Colonel Esports Summer Camp at the Terrebonne
	Parish Library – Main Branch from July 10 to July 14, 2023, with a
	final day of events at an Open House at the Nicholls State Esports
	Arena on the NICHOLLS campus on Saturday, July 15, 2023.
4.1.1.2.	Host and facilitate online registration for the Colonel Esports
	Summer Camp at the Terrebonne Parish Library-Main Branch
4.1.1.3.	Prior to executing said agreement, NICHOLLS shall provide TPCG
	with any and all documentation related to the hosting of the camp,
	including dates, times, and schedule for the camp.
4.1.1.4.	Provide eight (8) camp counselors and ensure that all camp
	counselors have been properly screened and are properly qualified
	to serve as camp counselors for minors.
4.1.1.5.	Arrange for and provide lunches for all counselors and campers for
	each day of camp.
4.1.1.6.	Provide facilities and support for Open House at the Nicholls State
	Esports Arena on the NICHOLLS campus on Saturday, July 15,
	2023, including lunch for parents.
4.1.1.7.	Provide waivers to be executed by the parents of all minors attending
	the Colonel Esports Summer Camp acknowledging NICHOLLS'S
	liability and disclaiming TPCG's liability.
4.1.1.8.	Award two one-thousand-dollar (\$1,000.00) scholarships to two
	deserving camp attendees who reside in the parish of Terrebonne.
4.1.1.9.	NICHOLLS agrees to provide TPCG with a copy of the current
	audited financials (or signed financial annual statements, 990's,
	and/or certification that audits are not required) for review by the
	Terrebonne Parish Council.
.1.2. TPCG shall:

4.1.2.1.	Purchase the gaming laptop computers, mice, and headsets
	necessary for the Colonel Esports Summer Camp.
4.1.2.2	Provide funds to NICHOLLS in the amount of Seventeen Thousand
	Four Hundred Twenty-eight and no/100 (\$17,428.00) Dollars.
4.1.2.3.	Install and set up, through TPCG's I.T. Department, the necessary
	software on the laptop computers.

4.2. Any and all funding stated herein is subject to the condition that there are no budget amendments during the term of this Agreement affecting the aforedescribed funding and dependent up the condition that there be no changes to the aforedescribed budgeted funds during the term of this Agreement.

4.3. NICHOLLS shall return any funds remaining at the expiration of this agreement and any funds determined by TPCG to be spent for purposes other than those authorized herein.

4.4. Consideration herein is for the entire agreement.

# 5. <u>TERM</u>

5.1 The term of this Agreement shall begin upon execution and shall terminate at completion of all services by NICHOLLS and all payments are made by TPCG.

# 6. <u>TERMINATION</u>

6.2. This Agreement shall be terminated under any or all of the following conditions:

- 6.2.1. By written mutual Agreement and consent of the parties hereto.
- 6.2.2. For convenience: By thirty (30) days written notice by TPCG to NICHOLLS.
- 6.2.3. Either party may terminate this Cooperative Endeavor Agreement for cause based upon the other party's breach of any terms and/or conditions of this Cooperative Endeavor Agreement; provided that the non-breaching party shall provide the other party written notice specifying the breach. If within thirty (30) days after receipt of such notice, the breaching party shall not have either corrected such breach or, in the case of a breach which cannot be corrected in thirty (30) days, begun in good faith and thereafter proceeded diligently to complete such correction, then the nonbreaching party may, at its option, place the breaching party in default and this Cooperative Endeavor Agreement shall terminate on the date specified in such notice.

# 7. <u>INSURANCE</u>

7.2. NICHOLLS shall procure and maintain, for the duration of this Agreement, insurance against claims for injuries to persons or damages to property which may arise from or in connection with NICHOLLS'S obligations as set forth in this Agreement. Minimum insurance requirements are as follows:

- 7.2.1. Minimum Limits of Insurance. Nicholls State University shall maintain limits no less than:
  - 7.2.1.1. General Liability: \$1,000,000 combined single limit per occurrence for bodily injury, personal injury, and property damage.
  - 7.2.1.2. Automobile Liability: \$500,000 combined single limits per accident, for bodily injury and property damage.
  - 7.2.1.3. Workers' Compensation Insurance to meet the applicable statutory requirements and Employers' Liability Insurance with limits of not less than \$1,000,000 and shall include:
    - a. Alternate Employer Endorsement
    - b. Voluntary Compensation Endorsement
  - 7.2.1.4. Professional Liability: \$1,000,000 per claim, \$2,000,000 annual aggregate.
- 7.2.2. Other Insurance Provisions:
  - 7.2.2.1. TPCG is to be added as "Additional Insured" to the required General Liability, Auto Liability, and Professional Liability policies.
  - 7.2.2.2. NICHOLLS and its insurers shall agree to waive all rights of subrogation against TPCG, its officiers, officials, employees and volunteers for losses

arising from work performed by the insuring party.

- 7.2.2.3. Each insurance policy required by this article shall be endorsed to state that coverage shall not be suspended, voided, cancelled by any party, or reduced in coverage or in limits except after thirty (30) days prior written notice by certified mail, return receipt requested, has been given to TPCG.
- 7.2.2.4. All policies above endorsed to be primary coverage to any other coverage.
- 7.2.2.5. Coverage should be endorsed to cover property "territory" of operations.
- 7.2.3. Acceptability of Insurers. Insurance is to be placed with insurers authorized in Louisiana, with a Best's rating of no less than A-V1.
- 7.2.4. Verification of Coverage. NICHOLLS shall furnish TPCG certificates of Insurance effecting coverage required by this article. The certificates for each insurance policy are to be signed by a person authorized by that insurer to bind coverage on its behalf. The certificates are to be received and approved by TPCG before work commences. TPCG reserves the right to require complete, certified copies of all required policies, at any time.

# 8. <u>INDEMNIFICATION</u>

To the fullest extent permitted by law Nicholls State University ("NICHOLLS") shall protect, defend, indemnify, save and hold harmless the Terrebonne Parish Consolidated Government from and against any and all claims, demands, expense, losses, suits, costs, actions, fines, penalties, and liability, whether actual or alleged, arising out of or resulting from injury, sickness, asbestos, lead, hazardous materials, disease or death to any person or the damage, loss, expense or destruction of any property, including loss of use resulting there from, which may occur, be caused by, or in any way result from any damages sustained by a NICHOLLS participant while in the course and scope of his or her duties under the employment of NICHOLLS, or which may occur, be caused by, or in any way result from any actual or alleged act, omission, negligence, misconduct, or strict liability of TPCG, its agents, contractors, sub-contractors, partners, affiliates, directors, officers, employees, servants, volunteers, anyone directly or indirectly employed by it, or anyone for whose acts it may be liable, including but not limited to acts related to the performance or non-performance of the Agreement herein entered into, including any and all costs, fines, damages (special, general, or punitive) penalties, expense and/or attorney fees, including but not limited to expert witness fees, incurred by the TPCG as a result of any such claims, demands, losses and/or causes of action including any costs associated with the enforcement of this indemnity provision except those arising out of the sole negligence of TPCG. This indemnification does not apply to any strict liability of the TPCG. NICHOLLS shall investigate, adjust, settle, contest to resolution, resist claims, handle, respond to, provide defense for and defend any such claims, demands, proceedings, judgments, or suits at its sole expense related thereto, even if such claim, proceeding, judgment, demand or suit is groundless, false or fraudulent. TPCG shall not waive any immunity to which it is entitled under law.

# 9. <u>ADDITIONAL TERMS AND CONDITIONS</u>

9.1 The failure of the either party to enforce any of the terms of this Agreement or to provide any of the supporting documentation in any particular instance shall not constitute a waiver of, or preclude the subsequent enforcement of, any or all of the terms or conditions of this Agreement.

9.2 Neither party shall assign its rights, privileges, and obligations, in whole or in part, in any manner except by operation of law without the prior written consent of the other party. In case of such assignment or succession so consented to, all of the conditions and provisions herein shall apply to the original party and such substituted party.

9.3 NICHOLLS shall not hire for this project contractors, independent, or subcontractors, unless approved in writing by TPCG.

9.4 This Agreement, including any attachments that are expressly referred to in this Agreement, contains the entire Agreement between the parties and supersedes any and all Agreements or contracts previously entered into between the parties. No representations were made or relied upon by either party, other than those that are expressly set forth. This Agreement may be modified or amended at any time by mutual consent of the parties, provided that, before any modification or amendment shall be operative and valid, it shall be reduced to writing and

signed by both parties.

9.5 The recitation and preambles of this Agreement are hereby made a part of the terms and conditions of this Agreement.

9.6 To the fullest extent allowed by law, this Agreement shall be governed and interpreted by Louisiana Law and the provisions of this Agreement shall be enforced and brought in the Thirty-Second Judicial District Court, Terrebonne Parish, Louisiana.

9.7 In case any one or more of the provisions contained in this Agreement shall for any reason be held to be invalid, illegal, or unenforceable in any respect, such invalidity, illegality, or unenforceability shall not affect any other provisions thereof and this Agreement shall be considered as if such invalid, illegal, or unenforceable provision had never been contained in this Agreement.

9.8 TPCG may be audited in accordance with La. R.S. 24:513. If the amount of public funds received by NICHOLLS is below the amount for which an audit is required under La. R.S. 24:513, TPCG shall monitor and evaluate the use of the funds to ensure effective achievement of the project goals and objectives.

9.9 It is hereby agreed that the Legislative Auditor of the State of Louisiana, and/or the Office of the Governor, Division of Administration auditors shall have the option of inspecting and auditing all data, records, and accounts of NICHOLLS which relate to this Agreement, upon request.

9.10 TPCG shall have the option of inspecting and auditing any documents/records of any nature related to this Agreement at TPCG's expense, and NICHOLLS shall produce the documents within five (5) days of demand. NICHOLLS shall not destroy any documents/records without prior approval of TPCG.

9.11 In the event funds are not budgeted or appropriated in any fiscal year for payments due under this Agreement for the then current or succeeding fiscal year, this Agreement shall impose no obligation on TPCG as to such current or succeeding fiscal year, and said Agreement shall become null and void, and no right of action shall accrue to the benefit of either party, their successors or assigns for any further payments.

9.12 Both parties agree to abide by the requirements of the following as applicable: Title VI and VII of the Civil Rights Act of 1964, as amended by the Equal Opportunity Act of 1972, Federal Executive Order 11246, the Federal Rehabilitation Act of 1973, as amended, the Vietnam Era Veteran's Readjustment Assistance Act of 1974, Title IX of the Education Amendments of 1972, as amended, the Age Act of 1975, as amended, and LRS agrees to abide by the requirements of the Americans with Disabilities Act of 1990, as amended. Both parties agree not to discriminate in its employment practices and will render services under this contract without regard to race, color, religion, sex, sexual orientation, national origin, veteran status, political affiliation, or disabilities. Both parties acknowledge and agree that any act of unlawful discrimination committed by either party, or any other failure to comply with these statutory obligations when applicable shall be grounds for termination of this Agreement.

9.13 NICHOLLS shall comply with all federal, state, and local laws and regulations, including, specifically, the Louisiana Code of Governmental Ethics (R.S. 42:1101, *et seq.*) in carrying out the provisions of this Agreement.

9.14 Neither party to this Agreement shall be responsible to the other party hereto for any delays or failure to perform caused by any circumstances reasonably beyond the immediate control of the party prevented from performing, including, but not limited to, acts of God.

9.15 NICHOLLS certifies that it has not employed and will not employ any person to engage in the performance of this Agreement who is presently, or at the time of such employment, an employee of TPCG.

9.16 NICHOLLS warrants that it has not employed or retained any entity or person to solicit or secure this Agreement, and that it has not paid or agreed to pay any entity or person any fee,

commission, percentage, brokerage fee, gift, or any other consideration contingent upon or resulting from the making of this Agreement. For breach or violation of this warranty, the TPCG shall have the right to annul this Agreement without liability or, in TPCG's discretion, to deduct from the contract price or consideration, or otherwise recover the full amount of such fee, commission, percentage, brokerage fee, gift, or contingent fee.

10.2. # **Colonel Esports and Terrebonne Parish Partnership**

Colonel Esports and Nicholls State University would like to create an educational gaming experience with Terrebonne Parish. This partnership would include a pilot summer camp with research and statistics to provide the parish at the end of the pilot program to assess the benefits and the satisfaction of the program. This summer camp would provide us an opportunity to not only teach the campers healthy habits and provide an opportunity for one-onone mentoring with our players who have experience competing on a collegiate and pro-am level, but also by offering an open house, provide parents with a better understanding of the benefits of gaming and how to get involved with their children's hobbies and interests.

So this camp is a sustainable experience for years to come, we suggest that with this partnership, if approved, the parish purchase suggested materials, and the university will invoice the parish for those items that are necessary. This would not only benefit the North Terrebonne library branch, who is eager to begin its own esports facilities, but also share in our experience of creating a welcoming, educational, and diverse environment that just so happens to involve gaming.

As of Fall 2020 statistics, over 27% of our student population are Terrebonne Parish residents. This is our largest parish demographic at Nicholls State University. By adding esports scholarships specific to some of our players we hope to give back to the community while placing a spotlight on how the parish council supports this program and our esports initiative to educate through gaming.

# Why Gaming?

Playing video games can have positive effects and benefits, when played in moderation. The most notable positive effects of gaming include:

- Improved cognitive abilities
- Improved problem-solving skills and logic
- Increased hand-to-eye coordination
- Improved multi-tasking ability
- Faster and more accurate decision-making
- Enhanced empathetic behaviors
- Better eyesight (false?) (attention to detail)
- VR and mobile games promote physical activity
- Games require you to persevere with your task to complete the goal of the game, which means they build up your grit.
- Non-native English speakers are able to learn English faster using video games
- Other benefits include better pattern recognition, strategic thinking, risk-taking abilities, and management

A recent study from 2015 from Australian and Chinese research teams showed that gaming increases the amount of gray matter in the brain that improves problem-solving skills and logic. Researchers performed fMRI scans on 27 professional gamers and found they had developed "heightened connectivity between certain subregions in the insular cortex." In practice, this translates to enhanced cognitive abilities, which include improved problem-solving skills and logic.

Many gamers play games that require a great deal of planning, strategic thinking and using logic to achieve goals within the game, so it makes sense that they will have enhanced development in areas of the brain dedicated to problem solving and logic.

Video games have even been proven to improve one's ability to perform tasks that require accuracy quicker and with higher accuracy. A study by James C Rosser Jr et. al. from 2007 examined laparoscopic (abdomen) surgeon training and included young surgeons that play video games to see what effects gaming would have on their ability to perform surgeries and other medical tasks.

The study found that surgeons who played video games in the past or recently had 37% fewer errors and completed the task 27% faster than non-gamers. Their accuracy also improved with more playtime. The study found that even with more modest playing time (3 hours a week), gamers performed better than non-gamers.

This study, along with others we have shared, suggests gamers do better at tasks that require speed, accuracy, and hand-to-eye coordination.

Eligible costs, as defined by the Act and the Rule incurred between the end of Recipient's final operating year under the grant being transitioned and the execution of this Agreement may be paid with funds from the first operating year of this Agreement.

HUD designations of Continuums of Care as High-performing Communities (HPCS) are published on HUD.gov in the appropriate Fiscal Years' CoC Program Competition Funding Availability page. # PROJECT SUMMARY (200 WORDS OR LESS)

The Greater New Orleans Foundation has announced the Next 100 Year Challenge Grant Program which seeks to award up to \$100,000 to ten non-profit grantees for nature-based infrastructure projects that are seeking larger funding (typ at the Federal level). The Bayou Cane Stormwater Management Basin lies within the 4,000 plus acre area which was recently donated to the Parish by Shell as the Terrebonne Parish Nature Conservatory. The \$6.7M Basin Project was submitted by TPCG under the Hazard Mitigation Grant Program as part of the Hurricane Ida recovery planning. If awarded, TEDFo would use the \$100,000 for the purposes of conducting an environmental review that would then be used towards the wetland enhancement to improve the efficiency of the stormwater basin and improve the habitat and ecology. There is no local match requirement for the grant, but the Parish's investment of the Bayou Cane Pump Station project will be highlighted in the application narrative.

# PROJECT PURPOSE & BENEFITS (150 WORDS OR LESS)

The 4,000-plus-acre Nature and Recreation Conservatory which will increase storm water retention by 1.7 billion gallons, with the potential to improve the parish's FEMA Community Rating System and reduce flood insurance rates all while improving water quality released back into the parish's natural habitat; and will also function as a recreational and tourism feature with boat/kayak launch; levee access for cycling, walking; birdwatching and observing the natural flora and fauna of the area. Although located within Council Districts 2 and 4, the benefits extend out to the surrounding areas in Districts 6 and 3. Furthermore, the area's ability to detain/retain that much stormwater will improve the overall drainage system by giving TPCG the ability to move water in and out of the basin as the circumstances may require thereby reducing the risk of flooding to properties both upstream and downstream in our watershed.




